RELEASE: In consideration of the service provided, I, for myself and any minor children for which I am the parent, legal guardian, or otherwise responsible, do hereby release Jumpin' Jack's Funland, LLC, its directors, officers, agents, employees, and volunteers from any liability and waive any claim for damages arising from any cause whatsoever (except that which is gross negligence). I further agree to reimburse you for all attorneys' fees and costs should I bring a legal action against you.
